## Summary

New orders for manufactured goods in August, up four consecutive months, increased $\$ 3.2$ billion or 0.7 percent to $\$ 470.1$ billion, the U.S. Census Bureau reported today. This followed a 6.5 percent July increase. Shipments, also up four consecutive months, increased $\$ 1.4$ billion or 0.3 percent to $\$ 481.3$ billion. This followed a 4.7 percent July increase. Unfilled orders, down five of the last six months, decreased $\$ 6.2$ billion or 0.6 percent to $\$ 1,078.6$ billion. This followed a 0.7 percent July decrease. The unfilled orders-to-shipments ratio was 6.60, down from 6.69 in July. Inventories, up three of the last four months, increased $\$ 0.2$ billion or virtually unchanged to $\$ 686.6$ billion. This followed a 0.6 percent July decrease. The inventories-to-shipments ratio was 1.43 , unchanged from July.

## New Orders

New orders for manufactured durable goods in August, up four consecutive months, increased $\$ 1.3$ billion or 0.5 percent to $\$ 233.2$ billion, up from the previously published 0.4 percent increase. This followed an

11.8 percent July increase. Machinery, also up four consecutive months, led the increase, $\$ 0.5$ billion or 1.5 percent to $\$ 31.2$ billion. New orders for manufactured nondurable goods increased $\$ 1.9$ billion or 0.8 percent to $\$ 236.9$ billion.

## Shipments

Shipments of manufactured durable goods in August, down following three consecutive monthly increases, decreased $\$ 0.5$ billion or 0.2 percent to $\$ 244.3$ billion, up from the previously published 0.3 percent decrease. This followed a 7.6 percent July increase. Transportation equipment, also down following three consecutive monthly increases, drove the decrease, $\$ 1.4$ billion or 1.7 percent to $\$ 81.6$ billion. Shipments of manufactured nondurable goods, up four consecutive months, increased $\$ 1.9$ billion or 0.8 percent to $\$ 236.9$ billion. This followed a 1.8 percent July increase. Petroleum and coal products, also up four consecutive months, led the increase, $\$ 1.6$ billion or 4.2 percent to $\$ 39.6$ billion.

## Unfilled Orders

Unfilled orders for manufactured durable goods in August, down five of the last six months, decreased $\$ 6.2$ billion or 0.6 percent to $\$ 1,078.6$ billion, unchanged from the previously published decrease. This followed a 0.7 percent July decrease. Transportation equipment, down six consecutive months, drove the decrease, $\$ 6.8$ billion or 0.9 percent to $\$ 728.1$ billion.

## Inventories

Inventories of manufactured durable goods in August, down three consecutive months, decreased \$0.6 billion or 0.1 percent to $\$ 420.4$ billion, unchanged from the previously published decrease. This followed a 0.8 percent July decrease. Machinery, down seven of the last eight months, led the decrease, $\$ 0.4$ billion or 0.6 percent to $\$ 69.1$ billion. Inventories of manufactured nondurable goods, up three of the last four months, increased $\$ 0.8$ billion or 0.3 percent to $\$ 266.2$ billion. This followed a 0.2 percent July decrease. Chemical products, up two of the last three months, led the increase, $\$ 0.5$ billion or 0.5 percent to $\$ 96.9$ billion. By stage of fabrication, August materials and supplies decreased 0.4 percent in durable goods and were virtually unchanged in nondurable goods. Work in process increased 0.4 percent in durable goods and 0.3 percent in nondurable goods. Finished goods decreased 0.6 percent in durable goods and increased 0.5 percent in nondurable goods.

## EXPLANATORY NOTES

Figures in text are adjusted for seasonality, but not for inflation. Figures on new and unfilled orders exclude data for semiconductor manufacturing.
"Virtually unchanged" indicates that the change is less than 0.05 percent for a percent increase or decrease.

## Description of the survey

This report is compiled from results of the U.S. Census Bureau's Manufacturers' Shipments, Inventories, and Orders (M3) survey, which is a voluntary survey authorized by Title 13 of the United States Code. This survey provides statistics on a calendar-month basis for manufacturers' value of shipments, new orders (net of cancellations), end-of-month order backlog (unfilled orders), end-ofmonth total inventory (at current cost or market value), and inventories by stage of fabrication (materials and supplies, work-in-process, and finished goods). Data published from the M3 survey are based on a panel of approximately 5,000 reporting units that represent approximately 3,100 companies and provide an indication of month-to-month change for the Manufacturing Sector. These reporting units may be divisions of diversified large companies, large homogenous companies, or single-unit manufacturers in 92 industry categories, which are combined into 65 publication levels due to the small monthly panel size. The survey methodology assumes that the month-to-month changes of the total operations of the reporting units in the M3 panel effectively represent the month-tomonth movements of all establishments that make up the category. The companies for which shipments data are currently reported or imputed in the M3 survey represent approximately 60 percent of the total value of shipments for manufacturing establishments in the 2017 Economic Census, and these companies include roughly 61 percent of the manufacturing companies with \$500 million or more in shipments in the 2017 Economic Census. The companies for which shipments data are currently reported in the M3 survey represent approximately 51 percent of the total value of shipments for manufacturing establishments in the 2017 Economic Census. Statistics based on the M3 panel differ from the results that would be obtained from a complete enumeration of all manufacturing companies. The M3 panel is not based on a probability sample; therefore, the sampling errors that are normally provided with sample surveys cannot be measured. Nonsampling errors are attributable to many sources. The use of company or divisional reports to estimate the monthly change for establishments is one source of nonsampling error. The use of primarily large companies to
